Rates are subject to legislative changes with respect to VAT. Rates quoted are only valid when booked via our call centre or directly with the hotel and are non-commissionable. Weekend rates will be discussed on an individual basis as required.

All reservations must be guaranteed for arrival and for settlement of accounts on departure with a valid credit card (Visa/MasterCard), or by direct invoicing authorisation (based on approval). The Hotel will not hold any reservations unless secured by one of the above methods. Cancellation is permitted on day prior to arrival up to 5PM with no cancellation charge. A cancellation number/email should be obtained for reference. Rooms cancelled after this time will be liable for a cancellation charge equivalent to 100% of the agreed nightly rate.

Amendment requests for earlier check out dates on already confirmed bookings, must be advised by email no later than 24 hours prior to the requested earlier check out date to avoid cancellation fees. Amendments for earlier checkouts received <24hrs prior to the earlier requested check out date will be liable to a cancellation charge equal to 100% of the nightly rate.

The hotel extends this rate in anticipation of 25 room nights per year. This agreement shall be subject to quarterly reviews, at which time production will be discussed. If production is not met, rates are subject to change.
